- 1. DATES & TIMES: Set-Up: Thursday, June 5: 10:00 a.m. (Committee volunteers will not be available until 10:00 a.m.)
Hours: Thursday, June 5: 4:00 - 9:00 p.m. Friday, June 6: 12:00 - 9:00 p.m. Saturday, June 7: 10:00 a.m. - 9:00 p.m.
2. FEE: FIRST-TIME PARTICIPANTS: \$75.00 per 10' x 10' space: Payment in full must accompany signed Rental Agreement.
3. ELECTRICAL REQUIREMENTS: Each vendor will be supplied with one 110v electric outlet and general tent lighting.
4. RENTAL AGREEMENT: Registrations will be accepted on a first-come basis.
5. REVOCATION OF AGREEMENT: Vendor agrees that the New Haven Festival Committee, Inc. may revoke this Agreement at any time.
6. TYPE OF CRAFTS: ALL work must be hand-crafted by participant. No exceptions.
7. TEAR-DOWN: All booth displays and merchandise must be removed from the tent and grounds after closing on Saturday evening, June 7, 2008.
8. PLACEMENT: Placement of vendor booths is at the discretion of the New Haven Festival Committee, Inc.
9. RV's / STORAGE TRAILERS: RV parking (with facilities) is available at Jefferson Township Park and Johnny Appleseed Park.
10. CANCELLATIONS: Full refunds will be given through May 1, 2008.
11. PARKING/LOADING & UNLOADING: The New Haven Park Department has mandated that vehicles IN Schnelker Park will be forbidden at all times.
12. DEADLINE: All applications are accepted on a first-come basis until all spaces have been reserved.
13. FIRE CODES: The New Haven Festival Committee, Inc. mandates vendor compliance with all Indiana Fire Codes.
